- ❖ Parent can confirm the Admission for AY 26-27 by paying the approved Application and Registration Fee. Application and Registration Fee is non-refundable once admission is confirmed.
- ❖ Transport fee subject to market condition and can be changed during the year.
- ❖ Uniform/ Books, Stationery and meals are charged separately.
- ❖ Sibling Discount is 10% of tuition fee for the younger sibling/s up to 2

- ❖ Tuition fees paid for full year in Advance may be allowed a 3% rebate in tuition fee only.

Key Policy Points

1. Billing Cycle

- a) I term billing- (June to Sept)- By 1st of May
- b) II Term Billing- (October to January)- By 15th of Sept
- c) III Term Billing- (February, May)- By 15th January

2. COLLECTION OF TUITION FEE, TRANSPORTATION:

- a) For new students all fee including registration and application fee will be due at the time of admission before activating student UNID
- b) Parents to pay Tuition and all other fees as applicable and invoiced within 15 days from the date of invoice.
- c) Transportation if opted will be billed with tuition fee. For opting out of Transportation minimum 2 months' notice is required.
- d) For any deposit of fees in cash (subject to rules) parents must obtain a receipt failing which school will not be responsible
- e) After due date, Rs 100/ per day late payment fee will be charged.
- f) For any dishonoured cheque, a fee of INR 1000 will be applicable
- g) Students have to clear all outstanding Fees (Tuition /Transport etc) in order to appear for any school-based assessments during year

3. WITHDRAWAL:

- a) For any withdrawal of a child before the end of the year or at the end of an Academic year, a prior notice of 4 months is required. In case of short notice, balance Tuition fees for the notice have to be paid.
- b) For withdrawal of any services (Transport/ Meal) a prior notice of 2 months is required. In case of short notice, balance Food / Transport fees for the notice have to be paid.
- c) Notice of withdrawal given before 15th of the month will be considered from that month and withdrawal notice after 15th will be considered from next month.

The above policy is at Management Discretion and can be amended any time.

Any deviations from policy requires prior approval from Board of Directors
